Dear Fellow Members,



Necessities Bags

The Club is excited to be launching a new service project in October. In support of Breast Cancer Awareness Month, we will be putting together Necessities Bags for mastectomy patients. Maureen Lutz founded Necessities, Inc., a 501c(3) charitable organization 5 years ago after her own personal experience gave her new perspective on how to prepare for her personal needs in the hospital and post surgical recovery at home.

The bags are free of charge and distributed exclusively through surgeons, nurses and hospital affiliated breast cancer support centers, throughout Fairfield County. These reusable totes are filled with essentials for wound care, hygiene and personal comfort for use after surgery and at home. Some of the items are small hand-sewn comfort pillows, cotton undershirts, super soft bandages, gentle paper tape, lip balm, flushable wipes, pocket pack tissues, water bottles, notebooks and pens, and information.

There is a big demand in November and December. The Club's goal is to assemble a minimum of 100 bags. The following donations are requested;

* Men's white tank shirts (sometimes called A-shirts) – such as Hanes or Fruit of the Loom brands.

Walmart carries multi-packs of 7 shirts for the best price.

* Flushable wipes – such as Cottonelle, Scott, Stop and Shop generic, Walmart's Equate.

A collection box will be outside the office during the month of September.

NEEDED IMMEDIATELY: people to sew small pillows. If you are interested, please call Audrey Rabinowitz (227-6010) for further information and instructions.

The schedule is:

Wednesday, October 6th at 7pm, we will pre-pack some of the items; Wednesday, October 13 at 9:30am, the bags will be assembled. A card will also be inserted in each one that states the bag was put together by members of the Club; the bags will be delivered to the hospitals and doctors' offices.

BYLAWS AND RULES COMMITTEE

Notice is hereby given in this Bulletin to the Voting Membership of revisions to the Bylaws which will be voted on at Club Day on Monday, September 13, 2010. Each Voting Member shall be given an opportunity to vote thereon in person or by Absentee Ballot available in the Club office.

The Bylaws and Rules Committee, after careful review and discussion, proposed to the Board the following revisions to the Club's current Bylaws, last updated in 2007. The Board approved and recommended acceptance of the revised Bylaws at its June 28, 2010 meeting.

The committee has made some minor changes to the Bylaws as a whole, consisting of section formatting, grammatical corrections, and upper/lower case and wording consistencies, which should increase readability and understanding.

Summarized below are underlined revisions which bring the Bylaws up-to-date with current and recommended practices:

Article III Membership, Section 2. - Active voting members and honorary non-voting members shall receive the Bulletin and annual Membership Directory.

Article IV Dues, Section 4. - If the dues remain unpaid, such members will be removed from the mailing list and annual Membership Directory.

Article IV Dues, Section 5. - Add the sentence: Dues of active members joining after May31 shall be the full amount for the upcoming year with no charge for June, July and August.

Article IX Community Services, Section 4. - Chair shall appoint a Scholarship Committee chair from members who have served on the Scholarship Committee for the previous one or two years.

Rewrite of the sub-committee's responsibilities - The Scholarship Committee shall be responsible for preparing and reviewing application forms, and awarding scholarships from the Club to selected high school seniors and one female adult who meet the established criteria for Scholarship grants. The Scholarship chair shall meet with the President, Finance chair and Community Services chair for approval of the committee's recommendations for Scholarship grants before notification or announcement. The Scholarship awards shall be presented at the Club's general meeting or other planned ceremony in June.

Article XI Standing Committees, Section 3. Communications Committee - remove the phrase excepting the major fund raiser from the responsibilities.

Section 7. Membership Committee - Change "shall maintain an up-to-date membership list" to shall ensure that an up-to-date membership list be maintained.

Article XII Permanent Committees, Section 5. Finance Committee - remove the underlined phrases from a) the financial operation and maintenance to the Club building and grounds with funds derived from membership dues, rentals and social events, and (b) the allocation of funds raised for philanthropic purposes.

Article XIV Special Interests, Section 2. Remove personal investments and paddle tennis and add Mah Jongg.

Section 6. Add the 1st VP: Special Interest section heads shall file a complete list of their members and any changes thereto with the Club's First Vice-President and office manager on a timely basis.
